ROAD MAINTENANCE MILLAGE**

Shall the expired previous voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution in Flynn Township, of 1 mill (\$1 per \$1,000 of taxable value), reduced to .9852 mills by the required millage rollbacks, be renewed at the original voted 1 mill (\$1 per \$1,000 of taxable value) and levied for four (4) years, 2020 through 2024 inclusive, for general operating purposes, raising an estimated \$30,993.00 in the first year the millage is levied.
