 - A representative met with the County Prosecuting Attorney to understand what level of enforcement the existing Nature Center Ordinances provide against individuals/groups violating them. The Sheriff's Department is also on board with enforcement of the ordinances when called upon to do so.
 - The only entrance into and out of the Nature Center will be the one on Peck Road. A turnaround at the end of the trail by the current Baldwin Road exit will be constructed so vehicles have a way to turn around.
 - DNR resources have been contacted to provide input regarding projects that would be beneficial for the center to pursue.
