- **REGULAR BOARD MEETING CALLED TO ORDER BY** Supervisor Grant Burgess at 8:00 p.m.

• ASSESSOR'S REPORT

- 2023 L-4029 Flynn Township Operating Millage form was completed and reviewed by Assessor Lupo with the board.
 - A motion was made by Clerk Robert Vinande and seconded by Trustee Bob Alexander to accept the 2023 L-4029 for Flynn Township. **MOTION CARRIED**
- The board discussed the timing of the next road millage renewal and that the current millage is not keeping pace with the costs required for maintaining the roads. Further discussion will be held.
- o Assessor Lupo discussed the state assessment audit coming to Sanilac County in 2024.
 - Requires an Assessor Assistant be named and required training completed. This resource would be available to answer questions in the event the assessor is unavailable. ACTION ITEM Clerk Vinande will place the Assessor Assistant discussion on the October agenda.
 - Multiple links to various information sources for property tax details need to be available on the township's website.

• PUBLIC COMMENT

- o High traffic concerns on Morgan Road and Sullivan Road
 - David Tippett noted there seems to be less farm traffic on the road and he inquired what the plans are for work to be done on the road.

- Supervisor Grant Burgess shared with the board and visitors that he knows there are plans in the works
 at the county level to do multiple improvements to the Morgan and Sullivan Roads; multiple entities
 will be funding the work. Timing TBD.
- Brown City District Library
 - Ms. Kulman informed the board the Brown City District Library was established in November 2022 by the Library of Michigan.
 - A portion of Flynn Township is within the Brown City District Library boundaries.
 - Ms. Kulman informed the board their may be a millage proposal on the February 2024 ballot and asked if they had any questions.
 - Treasurer Brent Banks inquired how the Brown City District Library could have been established without the knowledge of the Flynn Township Board; the answer to this is unclear.

"BE IT RESOLVED THAT THE COUNTY OF SANILAC, MICHIGAN, DOES HEREBY ACCEPT THE TERMS OF THE TF22-0179 PROJECT AGREEMENT AS RECEIVED FROM THE MICHIGAN DEPARTMENT OF NATURAL RESOURCES (MDNR), AND THAT THE SANILAC COUNTY PARKS COMMISSION DOES HEREBY SPECIFICALLY AGREE, BUT NOT BY WAY OF LIMITATION, AS FOLLOWS:

Public Comments: Scott Aughney, Jackson County, Michigan resident and organizer of Citizens for Electoral Justice, advised the Board of his investigation of public election records.

Bretton Jones, Sanilac County resident, provided the Board with packets of evidence and legal requirements regarding Michigan and Federal Election Laws he suspects have been broken and gave an overview of the same.

Don Johnston, Sandusky City Airport Manager, communicated to the Board about the growth, projects, and events taking place at the City Airport.

Alyson Edwards, City of Marlette resident, stated the importance of protecting our county and local clerks. Ms. Edwards further encouraged the Board to consider handcounting ballots.

Wilma Henderson, Watertown Township resident, thanked Clerk Hilgendorf for helping with journey of finding voter history. Ms. Henderson requested that the Board give Scott Aughney the time to give a broader presentation at a future board meeting. Ms. Henderson further plead with the Board not to lock our county down for Covid restrictions. Chairman Block responded. Ms. Henderson further requested that we continue the growth of the flags on the courthouse lawn by adding them to the walking path at Diamond Trail. Commissioner Heberling responded.

Kathy Spiegel, City of Sandusky resident, inquired as to what roll our Sheriff has regarding Covid, what roll the Board has with the Sheriff, and what influence the Board has over the Sheriff. Chairman Block responded.

Diane Ferguson, Watertown Township resident, requested that the Board give Scott Aughney more time at a future board meeting. Ms. Ferguson further shared concerns regarding various issues throughout the county.
